Admissions criteria

Admission to Reigate Grammar School depends upon a prospective pupil meeting the criteria required to maintain and, if possible, improve the educational and general standards for all its students commensurate with the school's ethos and aims. The school must also feel reasonably sure that it will be able to educate and develop the prospective pupil to the best of his or her potential and in line with the general standards achieved by the pupil's peers.

The school's criteria for admissions are:

- a. that a prospective pupil achieves a sufficiently high mark in the school's Entrance Examination to satisfy the Headmaster that he or she can cope with the general pace of learning at RGS;
- b. that a prospective pupil, in the judgement of the Headmaster, shows sufficient aptitude, commitment and willingness to benefit from the educational and extra-curricular opportunities on offer at RGS;
- c. that the school receives a satisfactory reference from the prospective pupil's school;
- d. that the school is able to meet the educational, social and personal needs of a prospective pupil;
- e. that there are sufficient vacancies in the appropriate year group or that, in the judgement of the Headmaster, the pupil will make an exceptional academic or other contribution to the school community.
- f. We will consider making early offers in exceptional circumstances, at the Headmaster's discretion, such as to further develop our public benefit partnerships with maintained schools, to help with Looked After Children or where there is a case to act early to promote social mobility via our means tested bursary scheme.

Age of entry

Students are normally admitted to the school at the ages of 11, 13 or 16. New students usually enter the school in September.

- The majority of our students enter at age 11 (Year 7). They come from a mixture of local primary and preparatory schools. In a typical year we take approximately 150-160 pupils at this stage.
- Pupils also join the school at age 13 (Year 9) from preparatory schools or from local schools. In a typical year we take approximately five to ten pupils at this stage. We recommend that a place for age 13+ entry is secured via our 13+ pre-testing arrangement, as outlined in our Prospectus Supplement.
- We also accept pupils into the Sixth Form (Year 12). There is no set number of places.
- Whilst entry at 12+ is not a usual entry point and will be dependent on space being available, it is possible we can help. Parents should contact the Head of Admissions before applying.

Registration

Parents may register a child at any time. There is a Registration Fee¹ (non-returnable) of £150 (UK applications) and £200 (overseas applications) which should be sent with the completed Application Form. Acceptance of this fee does not guarantee the offer of a place.

References

In advance of any entrance examination or interview, we will always ask each candidate's current school for a confidential written report. It is therefore important that parents inform their child's current school that they have lodged an application with us.

Entrance Deposit

On accepting a place at RGS, an entrance deposit of $\pounds 1,750$ must be paid. Of this sum, $\pounds 250$ is a lifetime subscription to the RGS Foundation's Reigatian Society. The remainder will be reimbursed at the end of a child's time at the school.

Where a pupil is withdrawn more than one term before admission, the entrance deposit will be forfeited. In the event of a withdrawal less than one term before admission, a full term's fees (less the amount of the acceptance deposit) will be payable in lieu of notice.

Scholarships and Bursaries

Scholarships at RGS are awarded for academic excellence and for outstanding ability and potential in music, sport and other extra-curricular activities such as art, drama, dance, chess and golf. The majority of scholarships either have no fee remission or are at a fixed amount (e.g. \pounds 1,000). In exceptional circumstances a percentage reduction of fees may be given.

RGS bursaries are intended to enable gifted children to attend the school irrespective of family income. The exact amount of fee reduction will depend upon family circumstances, however, families with a total gross annual income over $\pm 100,000$ are unlikely to qualify for a bursary.

Terms and Conditions

All offers of places are made subject to the school's Terms and Conditions, which will be made available to all successful candidates, or which can be obtained in advance from the Head of Admissions. Pupils are admitted to the school at the discretion of the Headmaster, whose decision is final.

Reigate St Mary's Preparatory School and Chinthurst School

Strong relationships exist between RGS and its junior schools Reigate St Mary's Preparatory and Choir School (RSM) and Chinthurst School and there is complete alignment in terms of expectations and understanding of the performance criteria which predicts future success at RGS. Pupils at RSM and Chinthurst may receive an early 11+ offer to RGS whilst they are in Year 5.

Pupils from RSM and Chinthurst may still sit the Entrance Examination if their parents wish them to do so.

Disability and Special Needs

The school welcomes applications from any prospective pupil with a physical and/or mental impairment. The school's policy is to apply the criteria stated above to all pupils and potential pupils regardless of any disability of which it is aware, and not to put any disabled pupil or potential pupil at a substantial disadvantage compared to any pupil who is not disadvantaged because of a disability. All applications will be judged fairly and the school will consider any reasonable adjustments that may need to be made to cater for the child's disabilities.

When applying for a place, parents are asked to write to the Headmaster setting out the nature and extent of any disability, and whether or not they wish the school to take any disability into account during the admissions process. In cases of doubt, parents should consult the school well in advance of any application.
